You or someone you live with suffering with:

- **A chronic respiratory, circulatory or mental health condition.** These include: Respiratory disease (respiratory infections, broncho-constriction in asthma, and chronic obstructive pulmonary disease).
- **A circulatory disease** (including cardiovascular disease, strokes and heart attacks).
- **Mental health issues** (including depression, anxiety, psychosis and bipolar disorders, dementia, intellectual and development disorders).

Do 2 or more of the following statements apply to you?

- Domestic Household EPC of D or below
- Net household annual income is below £36,400 (After bills and rent/mortgage)
- A member of the household is:
 - aged over 70
 - aged under 5
 - pregnant

or has the following health condition(s)

- respiratory disease (COPD, asthma)
