These schemes look at upgrading central heating systems and insulating properties. The measures installed typically require no financial contribution as the work is fully funded.

Eligibility criteria varies for all schemes, please read on or ask one of our team for more information.

These schemes can help!

How do I know if I'm eligible? Use the information below to find out:

Are you; someone else living in the property; your tenant receiving any of the following?

- Income Support
- Income Based Job Seekers Allowance
- Income related Employment Support Allowance (ESA)
- Universal Credit
- Working Tax
- Credit Child Tax Credit (income below £16,105 PA)
- Council Tax Reduction (exemption and discount do not qualify on their own)
- Housing Benefit
- Pension Credit

OR

Are you; someone else living in the property; your tenant suffering with:

- **A chronic respiratory, circulatory or mental health condition.** These include: Respiratory disease (respiratory infections, broncho-constriction in asthma, and chronic obstructive pulmonary disease).
- **A circulatory disease** (including cardio-vascular disease, strokes and heart attacks).
- Mental health issues (including depression, anxiety, psychosis and bipolar disorders, dementia, intellectual and development disorders).

ECO FLEX SCHEME

Do you; someone else living in the property; your tenant qualify for any of the following?

Route 1

EPC SAP bands D-G and households with an income less than £31,000 (Gross) this cap applies irrespective of the property size, composition, or region.

Route 2

SAP bands E-G households that meet a combination of two of the following although 1 and 3 cannot be used together.

1. Homes in Welsh provision LSOA 1-3 on the Welsh Index of Multiple Deprivation 2019. Your chosen energy company will explain this to you.
2. Householders receiving a Council Tax rebate (rebates based on low income only, excludes single person rebates).
3. Householders vulnerable to living in a cold home as identified in the National Institute for Health and Care Excellence (NICE) Guidance. Your chosen energy company will explain this to you.
4. A householder receiving free school meals due to low income.
5. A householder supported by a local authority run scheme, that has been named and described by the local authority as supporting low income and vulnerable households for the purposes of NICE Guideline. Your chosen energy company will explain this to you.
6. A household referred to the local authority for support by their energy supplier or Citizen's Advice because they have been identified as struggling to pay their electricity and gas bills.

Route 3

SAP bands D-G households that have been identified by their doctor or GP as low income and vulnerable, with an occupant whose health conditions may be impacted further by living in a cold home. These health conditions may be cardiovascular, respiratory, immunosuppressed, or limited mobility related.

Route 4
